ROAD~EO ELIIBILITY RULES FOR CONTESTEANTS:

- 1) CONTESTANTS MUST HAVE BEEN EMPLOYED FULL TIME AS A BUS OPERATOR IN SCHOOL BUS PASSENGER SERVICE FOR A TWELVE MONTH PERIOD.
- 2) DRIVER CONTESTANTS CANNOT HAVE BEEN SUSPENDED FROM WORK AT ANY TIME FOR A TWELVE MONTH PERIOD.
- 3) DRIVER CONTESTANTS CANNOT HAVE BEEN INVOLVED IN A CHARGEABLE VEHICLE COLLISION DURING THE SAME TIME PERIOD.
- 4) CONTESTANTS CANNOT HAVE BEEN CONVICTED OF A MOVING VIOLATION IN THE PAST 12 MONTHS.
- 5) DRIVER CONTESTANTS MUST HAVE A VALID B-P OR C-P LICENSE IN THEIR POSSESSION WHEN SUBMITTING APPLICATION AND ON THE DATE OF THE COMPETITION
